4. FIRST AID MEASURES

Handling Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

16. OTHER INFORMATION

Additional information **RESPIRATORS:** In general the use of respirators should be limited and engineering controls employed to avoid exposure.
